# R. J. Lamb

R.J. Lamb is a civil litigator. He has also had success on appeal, including successfully representing the firm's surety client in the appeal that resulted in the published decision of *S & S Paving & Const., Inc. v. Berkley Reg'l Ins. Co.*, 239 Ariz. 512, 372 P.3d 1036 (App. 2016). In that decision, the Arizona Court of Appeals found that a surety on a payment bond for a public construction project may not be sued for bad faith.

R.J. joined the firm in April 2013 and was named partner in January 2018.

Prior to joining the firm, R.J. was an associate attorney at a consumer law firm, where he represented consumers in claims arising out of various consumer protection laws, including the Telephone Consumer Protection Act, the Fair Credit Report Act, and the Fair Debt Collection Practices Act. This serves as invaluable experience as he now assists the firm's business clients in achieving their goals (e.g. enforcing consumer/residential loans and other consumer contracts) while complying with the consumer protection laws. In addition, he has used this experience to assist businesses in defending lawsuits filed pursuant to these consumer protection laws.

R.J. is a graduate of the University of Michigan (B.S. in Philosophy, 2004) and the Sandra Day O'Connor College of Law at Arizona State University (J.D., *Cum Laude*, 2011).
